Die in den beiden Mediationsprozessen entwickelten und erprobten Kriterien für die Auswahl von Wohnstandorten können auch unter

geänderten Rahmenbedingungen eine gute Basis für Entscheidungen bilden.

In der ersten empirischen Studie befragt die Doktorandin Familienrichter u.a. zur praktischen Effektivität der richterlichen

Anordnung nach § 135 FamFG. In einer weiteren empirischen Studie erforscht die Doktorandin Kriterien für die Geeignetheit einer Mediation in Fällen nach § 135 FamFG und widmet sich insbesondere der Frage, wann eine Mediation bei Trennung und Scheidung hilfreich ist.
